Paul,

I wish to review the Crewe Alexandra Football Club child protection and safeguarding policy (March 2018) and any related documents. Pleasingly the main policy is on your website however in order to understand it, a number of further policies are needed which are referred to in the document. These include :

1. *The whistle blowing policy* which seems not to be available on the club's website.

2. On page 8, the policy states - *Safer Recruitment 'The Club's Staff Recruitment policy and procedures set out the process in full and can be found on our website.'* Despite several global searches I have been unable to find it.

3. On page 14 under the heading *Related safeguarding portfolio policies,* it states '*This policy should be read alongside our other Club safeguarding policies and procedures,*' fifteen policies are listed. I was unable to find any of these on the club's website. Would you please provide me with either copies or links to each. Thank you.

Having had no reply to my last two emails I feel compelled to write for the final time to inform you that if I have not received the requested documents in full by tomorrow, Friday 20th April by 17.00 hrs., I will have to conclude that you and the officers of Crewe Alexandra Football Club ('CAFC') decline to fulfil my request.

Thank you for your email.

1. It has been necessary to write to Crewe Alexandra Football Club because on 9/4/18 as my email to Paul Antrobus detailed, the Child Protection and Safeguarding policy is only partly available on the club's website. On page 8 the policy states : *Safer Recruitment 'The Club's Staff Recruitment policy and procedures set out the process in full and can be found on our website.* They cannot be found, they are unavailable on the website.

2. On page 14 of the policy under the heading '*Related safeguarding portfolio policies,* it states : '*This policy should be read alongside our other Club safeguarding policies and procedures.*' Fifteen policies are listed. They cannot be found, they are unavailable on the website.

3. The 'whistle blowing policy,' is a component which must be read in order to understand the Club's safeguarding policy. It cannot be found, it is unavailable on the website.

You state:

Do you represent a media organisation, fan group or any other body. It's important to understand this as this is the context required to deal with this matter.

Like the Club, you seem to be suggesting that a decision to send me safety critical child safeguarding documents, which the Club mistakenly claims are publicly available on its website, is predicated upon me answering questions asked by both the Club and now you. You both seem to be attempting to assess whether I am 'a suitable person' to receive the documents. You may be surprised to learn I am under no obligation to provide any information to the club before it provides me or anyone else with documents which are central to the protection of children at Crewe Alexandra Football Club, and which through oversight are unavailable on the Club's website.

Furthermore, the Club (/you) demanding information of anyone who unnecessarily has to request all the safeguarding policies, could have a significant adverse impact on a live child protection matter. Mr Antrobus, the Designated Safeguarding Officer at Crewe, should be able to explain. Despite this, and as a matter of courtesy, my first email on 9/4/18 clearly stated the reason for my request.

On page 4 of its safeguarding policy, the Club claims '*safeguarding is everyone's business*.' Am I to be excluded?

If the Club does not provide the information by today (Friday) at 17.00 hrs, then it is a decision made by the officers of the Club. There is no point extending beyond this date - ten working days will have passed since my original request together with an unnecessary and avoidable amount of correspondence.

I remain optimistic the Club's officers will send me the documents electronically and in full.

Alison,

Would you please confirm the Club has appointed Mr Rowan to deal with the safeguarding matter I raised on 19/4/18 when I requested a full copy of the Crewe Alexandra Child Protection and Safeguarding Policy. At the time it was only partly available on the Club's website.

The email from Mr Rowan sent to me on Friday 20th April makes an already poor situation worse for those officers of the company who have statutory responsibility for safeguarding. Mr Rowan is applying corporate logic to my request rather than having any apparent appreciation of safeguarding 'statutory guidance.' First rule in this realm; apply experience.

Mr Rowan's email states :

Please do note that that the Club's policies are currently undergoing a review and during this period have been taken offline, which is why you have not been able to locate them.

This morning I took a time stamped screenshot from the CAFC webpage (attached) that still offers the Club's incomplete and therefore unsatisfactory child protection and safeguarding policy to those members of the public who wish to read it. Contrary to Mr Rowan's assertion, none of the '*related safeguarding portfolio policies*' that '*should be read*' as recommended in the Crewe policy, were ever present on the website so they cannot have been 'taken offline.' Their nonexistence was the very reason I found it necessary to write to the Club a fortnight ago. The Safeguarding and Child Protection Policy was approved by the board in March 2018 as stated on the cover of the policy. The '*Related safeguarding portfolio policies*' which are vital to the functionality of safeguarding at Crewe, should have been approved simultaneously, yet have never been available.

Mr Rowan considers it appropriate to 'assume' I am a 'supporter' to justify my request being dealt with under the Club's 'customer charter.' Putting anyone with a safeguarding inquiry / concern into a process that permits the club to not respond for six weeks is astonishing.

I hope the Club provides the information by return.

Dear Mr Perry

Thanks again for your email. I am hopeful, as a result of this latest communication, we can start to bring to an end this matter.

Mr Rowan is the Communications Director at the EFL and as such will not be directly dealing with the specific query. The advice of the EFL was sought when it was not clear which stakeholder group you represented. To be clear this was not an evasive tactic but one to fully understand how the Club should respond to your query.

We remain confused as to who you represent and it is our view that it would have been more helpful to have a more upfront discussion at the outset. For example, if you are a member of the media we would have communicated matters in a slightly different way, than say if you were a parent. As we are unaware, we had to make an general assumption.

That point, however, was never going to change the outcome of what is an important issue and, as previously communicated, we will be in a position to provide the policies referenced once a review has been completed by our external consultant. This is the simple reason why they are not available at present, either on or offline. Your comments in regard to the policies being 'taken offline' are noted and accepted.

I also think it is incredibly important to point out that whilst the Club does have a period of up to six weeks to respond, we would all be in agreement that it is in the best interests of the concerned parties to respond as quickly as possible, given such a sensitive subject.

The work currently being completed is part of a wider review of our policies and procedures in this area to ensure Crewe Alexandra continues to create a safe, positive and enjoyable environment for all participants in the Club's activities.

The Club is confident that robust safeguarding procedures are in place and will continue to respond appropriately to anyone raising concerns. We also remain committed to working with the statutory agencies to ensure that the safeguarding of children and adults at risk is prioritised.

I trust this clarifies your latest query and as indicated above, the Club will respond in due course.

Thank you for your email of the 24/4/18.

My safeguarding request remains simple. The introduction of Mr Rowan to manage my request was unhelpful and concerning. All I have politely requested are copies of the '*related safeguarding portfolio policies*' that Crewe states in its Child Protection and Safeguarding Policy, 'should be read.' These documents were not available on your website as you acknowledge in your most recent email.

You say in your email:

"We remain confused as to who you represent and it is our view that it would have been more helpful to have a more upfront discussion at the outset. For example, if you are a member of the media we would have communicated matters in a slightly different way, than say if you were a parent. As we are unaware, we had to make an general assumption."

As I said in previous correspondence both to you and Mr Antrobus, your assertion is wrong. I am requesting documents Crewe has omitted to provide on its website about a safety critical subject. No one is under any obligation to provide Crewe with personal information when asking for these documents. With the Club asking for such information, a safeguarding concern could disappear. Despite me explaining this repeatedly, the Club continues its mistaken attempt to blame me for its poor response to my simple request.

The Club now claims that the '*related safeguarding portfolio policies*,' which form an integral part of the Safeguarding and Child Protection Policy and which were approved by the board in March 2018, are undergoing review hence their unavailability. Your email continues :

"The Club is confident that robust safeguarding procedures are in place and will continue to respond appropriately to anyone raising concerns. We also remain committed to working with the statutory agencies to ensure that the safeguarding of children and adults at risk is prioritised."

The '*related safeguarding portfolio policies*' are an integral part of the Child Protection and Safeguarding Policy as the policy itself states. With these having been removed, both online and offline, how can Crewe be confident that 'robust safeguarding procedures are in place' and that the Club 'will respond appropriately to anyone raising concerns?'

Thank you for your email. I acknowledge receipt of the attached documents. In the interests of keeping my communications simple, I address the following points to Ms Bowler.

There remains a question I am still keen to have answered. The attachments in the email contain a May revision of the club document titled 'Child Protection and Safeguarding Policy' which was first uploaded to the Club's website during late March 2018. No policy had been available before then. The policy cover states that it was approved by the board in the same month - March 18.

Unfortunately the integral 'Related Safeguarding Portfolio Policies' that are key to understanding the club's policy were never uploaded to the club's website and it prompts one to speculate whether they ever existed, particularly in light of my next paragraph.

In the email from Ms Dyer today she kindly provided a revised version of the 'Child Protection Safeguarding Policy' that indicates this latest version was approved by the board in May 2018, and she kindly provided the following 'Related Safeguarding Portfolio Policies' :

- Whistleblowing policy
- Recruitment and Selection Policy
- Safeguarding Adults Policy
- Anti Bullying Policy
- Equality and Diversity policy

The question arises: how did the board approve a policy when the 'Related Safeguarding Portfolio Policies' which are integral to safeguarding are missing?


